Summary of Request: Proposal is to construct a storage building and laboratory on the existing Mid Valley Metro site. The building will have four bays to store equipment needed for the operation of the existing wastewater treatment plant. The building will also be used to store spare parts that are used to maintain the system. The existing onsite laboratory and office will be relocated into the new building and the existing space these uses currently occupy will be used to increase the number of blowers that will be required when the plant expands to it maximum approved capacity of 0.99 million gallons per day.
